

COMMISSION & REFERRAL PARTNER AGREEMENT

1. PURPOSE

The Partner agrees to promote and refer clients (guests, tourists, corporate travelers) to the Company for taxi services (Local, Outstation, Airport Transfer). In return, the Company agrees to pay a referral commission to the Partner.

2. COMMISSION STRUCTURE

The Company shall pay the Partner a commission based on the *Base Fare* (excluding Tolls, Parking, and Taxes) of the completed trip:

3. BOOKING PROCESS

- **3.1.** The Partner must send the booking details (Guest Name, Mobile, Pickup Time, Destination) via **Official WhatsApp Group** or Email to the Company.
- **3.2.** The Company will confirm the booking and share the Driver & Vehicle details with the Partner/Guest 30 minutes prior to pickup.
- **3.3. Rate Card:** The Partner must quote rates to the guest strictly as per the "Central India Cabs Standard Rate Card" provided. Overcharging the guest is strictly prohibited unless authorized.

4. PAYMENT SETTLEMENT

- **4.1. Cash Trips (Guest Pays Driver):**
 - If the guest pays cash to the driver, the Company will transfer the accrued commission to the Partner's Bank Account on a **Weekly / Fortnightly** basis (e.g., every Monday).
- **4.2. Pre-Paid / Credit Trips:**
 - If the Partner collects the full amount from the guest, the Partner shall retain their commission and transfer the **Net Balance** to the Company *before* the trip starts.
- **4.3. Cancellations:** No commission is payable if the guest cancels the booking or is a "No-Show".

5. OBLIGATIONS

- **5.1. Exclusivity (Optional):** The Partner agrees to treat Central India Cabs as the *Preferred Taxi Vendor* and will prioritize sending bookings to the Company.
- **5.2. Service Quality:** The Company guarantees to provide clean, AC cars with uniformed drivers. In case of service failure (breakdown/delay), the Company handles the guest recovery; the Partner is not liable.

6. TERMINATION

- 6.1. Either party may terminate this agreement with **7 days' written notice**.
- 6.2. Any pending commissions must be cleared within 3 working days of termination.

7. DISPUTE RESOLUTION

In the event of a dispute regarding booking amounts or commission calculations, the Company's electronic trip logs (GPS data) shall be considered final. Jurisdiction: **Nagpur Courts**.
