- **3.1. Valid License:** The User confirms they hold a valid Driving License and are not disqualified from driving.
- **3.2. Prohibited Use:** The vehicle shall NOT be used for:
 - Illegal activities (smuggling, transport of banned goods).

- Commercial passenger transport (taxi/shuttle service).
- Towing other vehicles or participating in races/rallies.
- Driving under the influence of alcohol or drugs.
- **3.3. Territory:** The vehicle must be driven only within the state limits of **Maharashtra** unless a specific permit for other states has been pre-arranged and paid for by the User.
- **3.4. Care:** The User is responsible for maintaining tyre pressure, oil levels, and general cleanliness during the rental period.

4. ACCIDENTS, DAMAGES & THEFT

- **4.1. Minor Damage:** For scratches, dents, or broken parts (mirrors/lights) occurring during the rental, the User is liable to pay the **actual repair cost + downtime loss** (rental charge for days the car is in the garage).
- **4.2. Major Accident:** In case of severe damage:
 - The User must immediately notify the Company and the nearest Police Station.
 - The User is liable to pay the **Insurance Difference Amount** (amount not covered by insurance) + **Downtime Loss**.
 - If the insurance claim is rejected due to User negligence (e.g., drunk driving), the User is liable for the **Full Value of the Vehicle**.
- **4.3. Theft:** In case of theft, the User must immediately file an FIR and hand over the keys/documents to the Company. Negligence (leaving keys in the car) will make the User fully liable.

5. TRAFFIC VIOLATIONS (CHALLANS)

- **5.1.** The User is solely responsible for any traffic violations (Speeding, Signal Jump, Wrong Parking) during the rental period.
- **5.2.** If a challan is received later (via camera), the Company will deduct the amount from the Security Deposit or legally recover it from the User.

6. FUEL POLICY

- **6.1.** The vehicle is provided with ___% fuel. It must be returned with the same level.
- **6.2.** If returned with less fuel, the User will be charged actual fuel cost + **₹200 service charge**. No refund is given for excess fuel.

7. INDEMNITY

The User agrees to indemnify the Company against all losses, liabilities, damages, injuries, claims, and expenses arising out of the User's use of the vehicle. The Company is not responsible for any injury or death of the occupants during the rental period.

8. JURISDICTION

Any disputes arising from this agreement shall be subject to the courts of **Nagpur** jurisdiction only.
