

VENDOR VEHICLE ATTACHMENT AGREEMENT

This Agreement is made and executed at Nagpur on this ____ day of _____, 20__, by and between:

1. SCOPE OF PARTNERSHIP

The Vendor agrees to attach their commercial vehicle(s) with the Company for the purpose of transporting passengers. The Company acts as an aggregator/service provider connecting the Vendor with customers for Local, Outstation, and Corporate duties.

2. COMMERCIAL TERMS & COMMISSION

- **2.1. Commission Model:** The Vendor agrees to pay a commission of ____% (e.g., 10% or 15%) to the Company on the total billing amount of every trip provided by the Company.
 - OR
- **2.1. Fixed Monthly Fee:** The Vendor agrees to pay a fixed monthly subscription fee of ₹ _____ irrespective of the number of trips.
- **2.2. Payment Cycle:**
 - **Cash Trips:** The Vendor/Driver collects cash directly from the customer. The Company's commission must be deposited by the Vendor weekly.
 - **Credit/Corporate Trips:** The Company will collect payment from the client. The Vendor's share will be settled via Bank Transfer on the **7th and 22nd** of every month.
- **2.3. Rate Card:** The Vendor agrees to operate according to the Company's standard rate card (Per KM / Fixed Package). No overcharging is permitted.

3. OPERATIONAL GUIDELINES

- **3.1. Kilometer Calculation:**
 - **Local Duty:** Kilometers/Time will be calculated from "Garage to Garage" (subject to a maximum limit of X kms for garage distance).
 - **Outstation Duty:** Kilometers calculated from Office to Office (Zero mile).
- **3.2. Toll & Parking:** All Toll Taxes and Parking fees will be borne by the Customer/Guest. The Driver must produce valid receipts to claim these.
- **3.3. Driver Allowances (Bata):** For outstation trips returning after 11:00 PM, a standard Driver Night Allowance of ₹_____ (e.g., ₹250/300) is applicable.

4. DRIVER & VEHICLE COMPLIANCE

- **4.1. Documents:** The Vendor must ensure the vehicle has a valid Permit, Fitness, Insurance, and PUC at all times. The Driver must hold a valid Commercial License (TR Badge) and Police Verification Certificate.
- **4.2. Uniform & Grooming:** The Driver must wear the Company Uniform (or formal shirt/trousers) and shoes while on duty. Slippers/Shorts are strictly prohibited.
- **4.3. Condition of Vehicle:** The vehicle must be clean (interior/exterior) and mechanically sound. AC must be functional at all times.
- **4.4. Branding:** The Vendor agrees to display the "Central India Cabs" sticker/branding on the vehicle as per Company policy.

5. PENALTY CLAUSES

The Company reserves the right to impose penalties or terminate this agreement for the following violations:

- **Duty Refusal:** Rejecting a confirmed booking without valid reason (Penalty: ₹500).
- **No-Show:** Driver failing to reach the pickup point (Penalty: ₹1,000 + Cost of backup cab).
- **Misbehavior:** Rudeness, intoxication, or harassment of passengers (Immediate Termination + Police Action).
- **Direct Business:** Attempting to solicit the Company's clients for direct personal bookings (Permanent Blacklisting).

6. INDEMNITY & LIABILITY

- **6.1. Accidents:** In the unfortunate event of an accident, the Vendor acts as the sole owner of the vehicle. All legal liabilities, police cases, insurance claims, and damages to third parties are the **sole responsibility of the Vendor**. The Company is not liable for any civil or criminal proceedings.
- **6.2. Goods/Luggage:** The Driver is responsible for the safety of passenger luggage. Any theft or loss due to negligence will be recovered from the Vendor.

7. TERMINATION

Either party may terminate this agreement by giving **15 days' written notice**. In case of breach of "Clause 5" (Misbehavior/Direct Business), the Company may terminate the agreement immediately without notice.

8. DISPUTE RESOLUTION

Any disputes arising out of this agreement shall be subject to the exclusive jurisdiction of the courts in **Nagpur, Maharashtra**.
